Member Benefits

Member benefits begin upon payment in full and acceptance of the terms and conditions. Any and all membership fees are non-refundable after opening day.

- Access to pool area including outdoor patio, bar and snack bar during hours of operation
- Pool & Social Events (Admission fee may apply)

Payment Information

All incidentals purchased from the club, including guest fees, food, drink etc. must be paid upon transaction. The Club will accept cash, debit and credit cards for incidentals. Only full members (golf/pool) will be allowed to put incidentals on their member account balance.

Membership Conditions of Use

In consideration of the membership and as a condition of using the Club Facilities, Member agrees to all risks associated with the use of the Club Facilities, including risks associated with the use of or proximity to the pool (e.g. struck by lightning, falling), and agrees to release and indemnify Club Operator from and against any and all losses, expenses, liens, claims, demands and causes of action of every kind and character for death, personal injury, property damage or any other liability, damages, fines or penalties, including, without limitation, costs, attorney's fees and settlements, whether or not based on the acts or omissions of Club Operator, resulting from, arising out of or in any way connected with the use of the Club Facilities by Member, the Member's family members, guests, approved designees, and their family members and guests. As used in this paragraph, "Club Operator" shall include

The Club at Castle Bluff, LLC., their respective directors, officers, shareholders, partners, members, agents, related companies, affiliates, predecessors, successors, assigns and employees, and all persons, corporations, partnerships and other entities with which they are or may in the future become affiliated. This paragraph shall survive the termination of this Agreement and Member's membership in the Club with respect to any property damage, personal injury or death occurring prior to such termination.

No Ownership or Equity Rights

The Club is not an equity club and no Member shall, by virtue of a Club membership, be an owner or partner of The Club or have any ownership or equity right or interest in The Club, The Club Facilities or any of the assets of The Club, or in any personal property owned, leased or utilized in connection with The Club. No Member shall have any right to any accounting or share in, or designate the use of, the revenues, receipts, income or profits realized from the operation, sale or financing of The Club or the assets a part thereof. Members are not liable for the debts or other obligations of The Club or Club, past, present, or future. No Member shall have any right to determine any management policies or procedures for The Club operations. Acceptance of a membership in The Club constitutes acceptance and agreement by the Member and such Member's spouse, children, designees, family members and guests to abide by these Rules, the House Rules and such additional rules and regulations promulgated from time to time by "The Club", as they may be adopted or amended from time to time by "The Club".

Personal Property

Each Member agrees to take precautions against theft and not to encourage theft by failing to properly secure all articles belonging to the Member or the Member's spouse, children, family members, designees and guests, brought on The Club property or in The Club Facilities. Each Member agrees that none of The Club, or the Manager, or any other person or entity is responsible or liable to the Member or the Member's spouse, children, family member, designee or guests for articles damaged, lost, or stolen in or about The Club premises or The Club Facilities, or for loss or damage to any property, including, but not limited to, automobiles and the contents thereof.

Member Conduct

Damage or destruction of equipment, furnishings or any property belonging to The Club, by members or guests, will be charged to and will be payable by the members responsible. Any falsification will require IMMEDIATE expulsion without a refund.

In no case shall any member(s) or his/her guest(s) reprimand, verbally abuse or intimidate The Club at Castle Bluff employees. If there is an issue that needs to be addressed please email us your concern at castlebluffgolf@gmail.com. Violation of this policy may result in the suspension or termination of the membership.

We ask that Members treat each other with consideration and respect.

Management

As the operator of The Club, Management retains the right to decide all issues regarding operation and Management of The Club. Management also reserves discretion to implement, revise, restrict, or otherwise control all aspects of the sale and/or benefits of Memberships and the benefits that Management grants holders of those Memberships. Management may change, alter, or discontinue the sale of Memberships at its discretion.

- The Member Agrees to abide by any rules and regulations set by the management.
- The management has the right to amend or change the rules and regulations in its sole discretion.
- The rules and regulations may be implemented or changed at any time during the pool season. All members will be notified accordingly of any changes.
- Management has the right to ask any patron to leave for non-compliance with any of the rules stated.
- The Club management reserves the right to close the facility for private events. Members will be notified.
- Any adult/kid parties, etc. are not allowed at the pool without consent of management. If you would like to book a private party please contact us at castlebluffevents@gmail.com.

Guest Policy

- A member must communicate with their guest(s) upon arriving to meet them at the pool entrance. Guest(s) are not allowed to enter the pool area on their own. Members and all Guest(s) must check in at the check-in window.
- All Guest(s) must pay the appropriate guest fee upon entering with their member.
- Guest(s) will be allowed Tuesday-Thursday, Friday-Sunday may be limited.
- Guest Fees:
 - Guest Fees are \$10/person all ages (2 & younger are free)

Water Bottle Policy

Pool members & Guest(s) will be allowed to bring their own mugs, cups, and tumblers, whether insulated or non-insulated, into the pool area. However, these containers must be empty and will be checked upon arrival. In addition, to ensure that everyone remains hydrated and refreshed throughout their visit, The Club at Castle Bluff will be providing coolers with ice water that will be refilled throughout the day. Ice will **only** be provided in an alcoholic drink purchased from the Club.

Safety Requirements

NO LIFEGUARD ON DUTY - Swim at your own risk.

- Never let children swim without supervision, even for a moment.
- Never let children be left unattended any time on the premises of the pool, patio, bathrooms, clubhouse, parking lot, etc.
- No food or drinks are permitted to be brought on the premises. This is a club wide policy.
- No outside mugs, cups & tumblers. Insulated/Non-insulated. No coolers of any kind are allowed.
- State licensing restrictions require that all alcoholic beverages and food be supplied by The Club at Castle Bluff.
- All beverages must be consumed on the premises and are not allowed to leave the facility.
- All food, snacks, candy etc are not allowed in the pool, pool area and bathrooms. Must be confined in the patio area only.
- The Club at Castle Bluff reserves the right to control the amount of alcoholic beverages on the property. Any non-compliance will result in confiscation of the beverage/s and possible disciplinary action.
- Do not dispose of any non-alcoholic and alcoholic drinks into the pool including water and ice from the club beer buckets. This disrupts the PH levels of the pool water.
- No chewing gum of any kind is allowed.
- No littering. Please help us to keep a clean and healthy environment.
- All trash should be always deposited in the trash cans.
- We are a drug-free facility. Use of marijuana on or about the Club Facilities is prohibited.
- No smoking or vaping allowed on the premises of the clubhouse, golf course, patio, pool and bathrooms.
- No chewing tobacco allowed.
- Must wear appropriate swim attire in the pool. No cut-offs, athletic shorts, biking shorts, biking tights, leotards or thongs.
- Street clothes, shoes/water shoes and socks are not allowed in the pool.
- Only one person is allowed on the diving board. Must wait to step up to the diving board until no one is on.
- Spitting, spouting water, or blowing your nose is prohibited in the pool.
- No one is allowed in the clubhouse with a swimsuit. Please wear appropriate clothing/swimsuit cover up and shoes. Must be toweled off/dry before entering the clubhouse.

- Personal articles should be placed on or near the chair/lounger. Please help keep the pool deck area cleaned and orderly. This will prevent any tripping, falls etc.
- No Suntan oil of any kind is permitted. This prevents slippery pavement, damage to pool filters, clogged drains, bacteria, stained loungers etc.
- No inflatable pool floats for lounging or large inflatables.
- Use the step ladder or shallow end steps to exit the pool safely.
- Do not unhook the divider rope in the pool that separates the deep and the shallow end as well as the rope in the baby section.
- Sitting or standing on the divider rope is prohibited.
- Do not let a child dive without proper supervision.
- No diving allowed on the sides of the diving board.
- No swimming is allowed in front of the diving board or under the board.
- No diving allowed in the shallow end of the pool.
- No rough play is permitted; running, pushing, horseplay, wrestling etc will not be tolerated on the premises.
- No improper language or shouting will be tolerated on the premises.
- No pets are allowed on the premises.
- Children wearing floatation devices will be restricted to the designated shallow area of the pool.
- Please use proper hygiene, wash hands thoroughly when returning to the pool after eating food and using the restroom.
- No regular sports balls of any kind are permitted.
- No hard plastic or rubber (water guns, frisbees etc allowed).
- No play equipment (ie., masks, fins, snorkels etc).
- May not enter the water if you have open wounds, warts, rashes, or infections/communicability.
- Children or members who are unable to swim and use a poodle noodle water, wings and small rings for flotation may only when accompanied by a parent or an adult in the water.
- Use of any pool equipment (skimmers, netting, pool brush etc) is for staff personnel only. See a staff personnel for cleaning of any debris from the pool.
- Any child that is not potty trained, must wear a waterproof swim diaper.
- Shoes must be worn at all times in the parking lot, pool/patio area, clubhouse and bathrooms.
- Pool members are not allowed to wander off onto the golf course at any time while at The Club.

- Do not urinate in the pool.
- Cover cough or sneezes with a tissue or use the inside of the elbows.
- Please do not drag or move the loungers from side to side without using the back wheels to maneuver them. Slightly pick up from the foot of the lounge and use back wheels to move it slowly.
- Protect the pump and drain system - the repairs are costly to all members.
